# Urgent Communication regarding the Abduction and Detention in the Gaza Strip of Persons with Disabilities

This communication is submitted on behalf of Israeli civil society organizations whose work is devoted to the protection and promotion of the rights of all persons with disabilities, as well as on behalf of the *Hostages and Missing Families Forum*. The Hostages and Missing Families' Forum is an independent body acting to increase diplomatic efforts and international support on behalf of some 200 families of individuals forcibly and involuntarily taken by Hamas and associated organizations to the Gaza Strip and held there since 7 October 2023.

The organizations represented here are listed at the bottom of this communication.

We request the Special Rapporteur to take urgent action regarding the hostages and abductees who were forcibly and involuntarily taken on 7 October 2023 from Israel to the Gaza strip by Hamas, as a part of the horrific, extensive and premeditated attack that was carried out against civilian towns and villages in the south of Israel.

#### Facts

In the early morning hours of October 7, 2023, Hamas launched a massive rocket barrage on civilian areas in southern and central Israel. Simultaneously, Hamas militants crossed from Gaza into Israeli territory and attacked numerous Israeli towns and other communities situated in the vicinity of the Gaza Strip. In the course of this attack they brutally murdered and injured hundreds of people in their own homes, among them infants and older people. The number of confirmed deaths of Israeli victims of this attack has exceeded 1,300. Over 3,300 others have been wounded.<sup>1</sup> Many others are still missing and it is unknown whether they have been killed or taken by Hamas.

There are presently (16 October) at least 199 individuals whose families have been formally informed that their loved ones have been abducted.<sup>2</sup> These persons are arbitrarily detained incommunicado by Hamas forces in the Gaza Strip, with no information provided regarding their fate and whereabouts and with no contact with the outside world. Among them are persons in situation of particular vulnerability,<sup>3</sup> including children and older persons with disabilities.

So far, it is known that among the persons confirmed as being held hostage are three children with autism, a child with a life-threatening allergy, a child suffering from asthma, an adult with an auto-immune disease, and an adult with personal special care needs. The families of these individuals have requested that their names not be divulged at this time. Family members of hostages identified their relatives that include Crohn's disease, elderly persons with dementia and Parkinson's disease, a person with diabetes who is dependent on insulin, as well as persons who have recently undergone massive surgery and are dependent on medication.<sup>4</sup> The families of all these people have already been officially informed by the Israeli authorities that their family members are among the hostages.

# Link to a Preliminary Medical Report of the Missing/Abducted people by Hamas

Hamas Leaders have confirmed that they are holding hostages and abductees. Leader Salah Al-Arouri has confirmed that '[Hamas has] a large number of prisoners'.<sup>5</sup> Abu Obeida, spokesman of Izz ad-Din al-Kassam, later stated: 'our Mujahideen captured a very large number of enemy elements in all locations of combat and confrontation and took them to the places of detention by the Al-Qassam Brigades'. He added that 'the enemy's prisoners are in the same danger as our people are in the light of the aggression in the Gaza Strip, even that some of them have already been killed as we announced at noon today'. He explicitly noted that the abductees were being held as hostages.<sup>6</sup> In another statement he threatened to execute hostages so long

as Israeli forces continue their military action.<sup>7</sup> According to Islamic Jihad Secretary General Ziyad al-Nakhala, the Islamic Jihad is holding at least 30 of the abductees.<sup>8</sup>

From pictures and video clips published on social media and in the international media it appears that the captives have suffered torture and cruel, inhuman, brutal, and violent treatment during and after their abduction. We therefore have every reason to believe that the lives and basic rights of the hostages and abductees in Gaza are under immediate risk of the utmost gravity, in particular those of them who are with disabilities.

# Status of Hamas:

Hamas is a political and military organization currently governing de facto the Gaza Strip. The latter is recognized by UN organs and specialized agencies as constituting part of the territory of Palestine, which is a non-member observer State in the UN.<sup>9</sup>

As the de facto authority exercising governmental powers in the Gaza Strip, Hamas is not only directly responsible for the abductions that took place on or about 7 October 2023, but also accountable for the provision of information about, and communication with, individuals held within the territory under its control.<sup>10</sup>

In addition, Palestine, as a non-member observer state, incurs international responsibility for serious human rights violation occurring within its territory. Even where it does not effectively control. It should take all measures within its power to suppress the crimes and human rights abuses which Hamas and other armed groups are committing in the Gaza Strip, as confirmed by the Committee on Persons with Disabilities itself in its March 2023 views concerning *Mangisto and Al-Sayed v Palestine*.<sup>11</sup>

#### Subject matter of the communication

The holding of persons with disabilities in the context of armed conflict, incommunicado and without the healthcare on which their lives and well-being depend, constitutes a violation of numerous rights of persons with disabilities as enumerated in the Convention on the Rights of Persons with Disabilities, in particular articles 4 (general obligations), 10 (right to life), 12 (equal recognition before the law), 14 (liberty and security of person), 15 (freedom from torture), 16 (freedom of exploitation, violence and abuse), 25 (health) of the, read alone and in conjunction with Article 11. The taking of hostages itself constitutes a gross violation of international human rights law and humanitarian law, amounting to war crimes and crimes against humanity.

In order to avoid further irreparable damage to the victims, we request that the Special Rapporteur demand of Hamas and Palestine to immediately and unconditionally release all hostages and abductees. Pending such release, Hamas should provide information regarding the fate and whereabouts of the hostages and abductees, and guarantee their safety and access to medical care, especially in relation to their disability.

Every day that passes without information regarding the fate, whereabouts and medical condition of hostages and abductees, without providing them proper medical care, constitutes an imminent and substantial risk to the lives and to health of all hostages and abductees, and especially those with disabilities, who are in need of special care. This fear of risk is even more substantial considering the horrific videos of the massacre and the images which have already distributed by Hamas on social media Every day that passes in this situation endangers life and constitutes torture and a cruel and inhumane treatment, causing irreparable damage to their lives and to their health.

# Request for urgent action

Urgent action, to be used in situations that may require immediate attention in order to avoid serious violations of the Convention,<sup>12</sup> is eminently required when persons with disabilities are being held hostage and incommunicado, with no information as to their physical and mental situation and needs. The need for urgent action is particularly great given that the abduction of these persons took place in the course of armed conflict, which puts persons with disabilities in a situation of risk and places a particular obligation on states to take all necessary measures to ensure the protection and safety of persons with disabilities.<sup>13</sup> Urgent action is furthermore appropriate to ensure, in line with the call by the Security Council, on all parties to armed conflict to allow and facilitate safe, timely and unimpeded humanitarian access to all people in need of assistance.<sup>14</sup>

We urge the Special Rapporteur to consider the initial information provided herein and to specific measures to rectify the situation,<sup>15</sup> including a direct approach to Hamas as well as the issuing of a strong declaration, principally demanding Hamas immediately and unconditionally to release all persons who were abducted from Israel, and held hostage or otherwise detained in Gaza; and, pending that release, to ensure that they are all treated with humanity and respect. This includes the receipt of proper medical care and supply of essential medication for those who need it, and the provision of information regarding the hostages and means of communication with them to the families of the abductees. This specific request does not in any way diminish from the gravity of the overall actions taken by Hamas and associated groups and the rights of all abductees to be released immediately and unconditionally.

In light of all of the above, and on behalf of the organizations mentioned, we request an urgent intervention and use of all measures to further the efforts to secure the release of all hostages held by Hamas.


